INTRODUCTION

The New Zealand Wound Care Society Inc (NZWCS) is a voluntary organisation made up of health care professionals from a variety of disciplines who share a common interest in wound management. As an organisation it gives its members an opportunity to share experience, expertise and knowledge providing a forum to network with other members throughout the country. The primary objectives of the society include:

- Improve outcomes and quality of life for patients with wound and skin integrity problems.
- Provide and encourage best practice wound management across all health care settings.
- Be a recognised voice at national and local level in any issues relating to wound healing or maintaining skin integrity.

To achieve this, we focus on education and professional development, as well as fostering and encouraging an evidence-based approach to wound management. We hold regular local education sessions and study days, organised by Area Coordinators, and a biennial national conference.

Currently there are thirteen NZWCS branches across New Zealand: Northland, Auckland, Waikato, Rotorua/Taupo, Bay of Plenty, Manawatu/Palmerston North/Wanganui, New Plymouth/Taranaki, Hawkes Bay, Wellington, Marlborough/Nelson, Christchurch, Dunedin, and Southland.

This draft strategic plan identifies the NZWCS's vision, mission, values and strategic areas of focus for 2019-2024. NZWCS Executive Committee members, our administrator and external subject matter experts contributed to the creation of this strategic plan which will continue to build the society over the next five years 2019- 2024.

The NZWCS needs to enable health policy changes influencing decision making towards the creation of methods to improve outcomes, manage costs and reduce and manage wounds more efficiently and effectively. Through a variety of means the NZWCS must be able to affect policy, organisations, health care providers, consumers, clinicians and whanau at various levels.

Significant changes that can be influenced and improved include:

- the way wounds are assessed
- the way that consumers at risk are identified
- the approach to treatment
- the healthcare cost of all the above

There is an ongoing need for the implementation of international best practice into New Zealand. We must be continuously aware of competing priorities with skin and wound issues and must work to ensure wound management is at the forefront of the agendas of the influential bodies and top of mind for healthcare providers. In fulfilling this mandate, the NZWCS is committed to collaborate with organisations that have national and international networks and expertise.

The Society is focussed on establishing clear goals for the future. Achieving these goals is largely determined by the strength of partnerships and engagement of key stakeholders that together with the NZWCS support these efforts to improve the quality of wound management in New Zealand.

- Implementation of our new 5-year Strategic Plan. This will help us to focus our work programmes and achieve our objectives. The strategic plan sets the direction for the future of the NZWCS. This draft needs to be completed, but we are well on the way. On an annual basis, the NZWCS will report to its membership on the implementation of the Strategic Plan.
- Finance Governance Group. In order to increase transparency of our financial reporting, forecasting and improved governance we have created a finance governance group.
- We will continue to prepare and deliver a programme of activities to educate, inform and serve the continuing professional development for people who have a responsibility for the delivery and provision of wound prevention and management.
- We expect to have new international best practice guidelines for venous leg ulcer and pressure injures becoming available in 2019 and 2020 and a planned rollout and implementation are being developed to support these.
- Increasing international networks and collaborations. We are working towards developing more robust networks with our Australian and Pan Pacific colleagues to share information and resources for the benefit of all.
- We will continue to engage with Government agencies such as ACC, MoH and HQSC as subject matter experts, and the society will increasingly become consultants that can invoice for our specialist services.
- To support relevant research opportunities that will raise the profile of wound management related research and best practice in New Zealand
- Membership has continued to increase; alongside this we are developing new ways to improve our membership offerings and experiences.

We had a fabulous conference in Dunedin in May. The speakers and quality of the programme is of an international calibre and the social function was magical! We look forward to planning 2021 in the North Island.

I would like to acknowledge Pam Mitchell and Susie Wendelborn who are stepping down for the Executive Committee this year. Susie has been an integral leader in the Nelson and Marlborough region and her expertise will be sorely missed. We thank her mentoring so many nurses and supporting positive outcomes for clients in the regions. Pam has been our representative in Canterbury for a very long time and over the last few years has been the NZ representative for the International Pressure Injures Guidelines. Pam is now stepping down from this group, to which they acknowledged Pam for her significant input and expertise over the years. Thank you, Pam, for representing NZ so well. We look forward to your ongoing engagement in Pressure injuries in NZ.

As you will know I am choosing to step down this year, allowing fresh leadership and opportunities for other people. I would like to extend a huge thank you to all the members, area coordinators, advisory groups, committee members and Jeannette for your support over the last few years. It has been a privilege to be able to support the Society as a committee member, Vice President and President. The Society is growing every year as a result of the hard work that has been put in by many people over many years. 

On the table for discussion is still proposals for:

- A health professional who can work on many different projects that the NZWCS have happening now. The contract would vary depending upon the project and the candidate would need to be flexible. Researcher and project manager in one package. Propose 0.2 FTE (8 hours per week) For example an RN on step 6 as of May 2019 would have a base rate of \$75,132 per year. Cost per fortnight before tax \$577.92 per fortnight (taxed \$404.54) Per year \$ 15,025.92 depending on tax end up \$10,518.14. Propose we trial for a year and review the progress.
- Also increase in pay rate for Jeannette
- Increase in corporate membership fees
- Development of a governing financial group see Terms of Reference (TOR) this will help to enable the long-term management of the society as you can all see over \$300,000.00 passed through the books this year.

By being financially sustainable this will enable to society to engage in international and national guidelines groups and expert panels. PRESSURE INJURY ADVISORY GROUP (PIAG)

Introduction:

New Zealand Pressure Injury Advisory Group (NZPIAG) consists of NZWCS members with expertise and a special interest in pressure injuries.

Activities:

Stop Pressure injury Symposium 6th November 2018. In conjunction with ACC, this symposium provided a wealth of knowledge from various speakers on evidenced based practice for prevention and management of pressure injuries. There were also trade displays, national initiatives, case studies and a panel discussion with representatives from HQSC and MOH. These presentations are available as resources on the NZWCS website.

Global STOP Pressure Injury Day 15th November 2018. The aim of the day was to raise awareness of pressure injuries with prevention and management guidelines. Facilitation of seminars and workshops were organised by regional area committee members and coordinators and the photographs received demonstrated the diversity of the education given.

International Pressure Injury Prevention Guideline 2019 - Pam Mitchell will attend the launch of the guideline in Los Angeles, USA 15 & 16 November 2019. Pam is part of the Pan Pacific Pressure Injury Assoc (PPPIA) and together with representatives from EPUAP and the NPUAP have formed the Guideline Governance Group (GGG) to update the international PI guideline. This document includes the latest evidence and will be an invaluable resource for all health care professionals and institutions.

Aged Care Facilities (ACF) – In ACF there is a lot of disparity in equipment. A guideline is to be developed, in conjunction with ACC, which outlines the responsibilities of ACF to provide suitable equipment and will enable national consistency to prevent and manage pressure injuries.

ACC Guiding Principles document. This document is being implemented by almost all DHB. ACC has funded positions for 2 years to implement the 6 guiding principles in pressure injury prevention



Some progress has been achieved regarding the 2nd Edition of the Venous Leg Ulcer Guideline. It has been acknowledged that NZWCS members provided a significant contribution to the guidelines. The guideline delay is due to independent reviewer feedback from the National Health & Medical Research Council. Geoff Sussman Chair of Wounds Australia and the Wounds Australia Board support the guideline to come to fruition and make the necessary amendments. The Guideline Development Group have developed a plan, timeline and budget to complete the 2nd edition. This will involve members to review new literature and add or amend the chapters accordingly. We anticipate commencing work in 2020.

Wound Bed Preparation Working Group

Introduction

The Wound Bed Preparation Working Group (WBPWG), under the NZWCS umbrella, was formed as a result of an identified need to have a user-friendly Guideline developed to guide improved consistency in clinical practice knowledge associated with appropriate, evidence-based options for preparation of the wound bed.

Activities:

Purpose of group:

The purpose of the WBPG group is to compile and provide robust, evidence-based guidelines on wound bed preparation for clinicians to use in practice.

Where we are now:

The original purpose has been met and the document has been through the Education group twice. The first time there were several amendments which were actioned and the second time there were only minor adjustments. The WBPG was presented in outline at the NZWCS 2019 Conference with the hope it would be available around September 2019 for clinicians to use.

Completing this document made the group realise that there is a next step which is around conservative sharp debridement, and this is an area with several considerations to go with it. The discussions and minutes reflect that this also led into the consideration of competencies or standards and additionally that podiatry involvement would assist with development of these. The first meeting with the addition of 2 podiatrists was held in July, where several differences were identified, the key one being the importance of defining conservative sharp debridement against sharp debridement which is usually carried out by podiatrists, and occasionally by experienced registered nurses. It was agreed that the group would consider and discuss this at the next meeting. We have obtained podiatry credentialing information from Australia, but it is noted that this is tied in with a commercial firm. We are waiting to obtain further nursing information from Australia. We also have the Tissue Viability competency framework from the UK which is extensive and progresses from generic – knowledge of skin and ability to recognise wound infection right through to advanced knowledge and leadership in this field. This is a nursing document.

What did emerge from the combined meeting was marked differences between nursing and podiatry training and expectations associated with the term debridement when it involves using a sharp instrument(s). Another consideration may be whether for the sharp and conservative sharp debridement sections there are in fact 2 separate documents, with the WBPG providing the basis for practice for both parties up until that point. The training available around sharp debridement is also an issue as there are major differences in this and availability in NZ in terms of podiatrists and registered nurses.

The Bay of Plenty region continues to grow its population and as anticipated the winter is proving to be a very busy season for the Bay.

Tissue viability service still consists of one team member however with a strong focus on pressure injury reduction and subsequent prevention the potential for further support from ACC funding is an exciting prospect within this area.

There has been a very pro-active approach to pressure injury prevention especially the importance of correct grading and clinical terminology related to this. A video has been complied for all staff to watch so that everyone involved in pressure injury management has adequate skill and knowledge to recognize pressure injury grades. There has also been a pressure injury prevention intranet page set up internally where staff can find, not only local information on pressure injuries (the grading video, audit results and protocols) but also national documents. Also, on this page are the NZWCS pressure injury prevention leaflets in a variety of languages. This one stop shop also provides link to equipment information and identified tissue viability resource nurses within the organization

The Bay of Plenty product selection guide was launched 2 years ago and is updated on an annual basis. This has proved to be a very useful clinical decision-making tool to assist staff in product selection. The tool has recently been adapted for district nursing and a generic version is planned for aged residential care (ARC). The electronic version of the tool is hyperlinked to provide user information on the product.

The ARC wound care study day has become an annual event in the bay. This day generally attracts over 90 registered nurses and involves a series of workshops on clinical decision-making and appropriate product selection. This year's focus will be on pressure injuries and skin tears using the ISTAP recommended skin tear best practice.

It has been pleasing to note that in the 4 years that these events have been delivered the quality of referrals and instigation of treatment regimens with research-based rationale has improved. Referrals to the TVN are generally made by a detailed descriptive referral document and photography. This is proving to be a very time efficient and effective assessment method.

The Taranaki DHB Leg Ulcer Clinic is participating in the research project regarding validation of a risk assessment tool for early detection of patients at risk of delayed healing or recurrence of venous leg ulcers. November 2018 – celebrated National Stop Pressure Injury Day with a display at Wairau Hospital corridor promoted with equipment/pamphlets, cupcakes and a quiz to win two cakes. For 2019 the committee decided that we would only hold two branch education evenings for members due to the bi-annual conference taking place in May, which would also serve as education offered.

The first education session was held on the 21st March. The topic was "What Lesions Should be Referred". We had two presenters who gave their own different slants on the topic.

Mr Barnaby Nye a Plastic Surgeon in both the public and private sectors spoke along with Dermatologist Dr Caroline Mahon. We had a good attendance with 64 members registering for the evening.

Mr Nye spoke on the importance of early diagnosis of lesions, how this saves lives, and that diagnosis gets better with experience. In the public system, the Plastics department at Christchurch Hospital will only see malignant lesions that are life threatening and urgent. Mr Nye explained that lesions on the palms of hands and soles of feet need to be given specific attention, as do lesions greater than 20mm, as they are at increased risk of developing melanoma, and those that are especially small. In addition, high risk areas are ears, lips, intraoral sites. Variations in a lesion is what you look for. If there is uncertainty about diagnosis, don't just watch a lesion, as one needs a definitive diagnosis of malignancy. Be on the lookout for traumatic wounds that won't heal in two weeks, lesions that are itchy, bleeding, growing lesions and ones that come with an inconsistent story.

Our second speaker was Dr Mahon who discussed SCC- tumour of the epithelium. She envisaged that risk factors included: fair skin type, lots of sun exposure, HPV infection, immunosuppression, age, and smoking. SCC can arise out of any chronic wound even a burn injury; this is thought to be due to the chronic inflammation leading to dysplastic squamous cells. They require urgent treatment as they spread to lymph nodes. Red flags include: if a wound extends, fails to heal, has focal proliferation- heaping asymmetric wound edge or a central mass within the ulcer, worsening pain. SCC in Epidermolysis Bullosa were also discussed and the difficulty involved with diagnosing these and how these patients know there skin well and must listen to our patients concerns.

We appreciated the attendance of two trade exhibitors from AinsCorp and Douglas Pharmaceuticals Ltd who sponsored light refreshments along with their trade displays.

Or next education session will be in October, with no topic yet confirmed.
